A. 45th Annual General Meeting (“AGM”)

At the 45th AGM of the Company held on 10 October 2006, the shareholders of the Company had approved all the ordinary resolutions and special business as set out in the notice of the AGM.

B. Extraordinary General Meeting (“EGM”)
